 - o Gutters to be thoroughly cleaned twice a year. The Board approved.
 - Request to have owner's responsible for snow removal from driveways and sidewalks. The motion is pending further discussion and clarification.
 - Pat Carlyn and Cathy Leedom motioned to have the Clubhouse rental fee be increased to \$100 from \$50 and effective immediately with the existing reservations be grandfathered in at \$50,
 - The Board approved the motion.
