AMENDMENT OF THE DECLARATION OF COVNEANTS, CONDITIONS, AND RESTRICTIONS FOR LAKE WASHINGTON CONDOMINIUM

In accordance with RC Chapter 5311 and pursuant to paragraph 9 (Amendment of the Declaration and By-Laws located at 73398C03) of the Declaration of Covenants, Conditions, and Restrictions for Lake Washington Condominium, recorded at "73398B04 through 73399A05" of the Montgomery County, Ohio records and via the authority of execution by 75% of the voting power of the Association:

The owners executing below do vote affirmatively hereby to amend paragraph 3, The Purpose and Restrictions on use of Condominium Property (B) <u>Restrictions</u> (11) <u>Rental of Family Units</u> (appearing at 73398B10) in the following respects:

The sentence:

"Other than the foregoing obligations, the owners of the respective family units shall have the absolute right to lease same provided that lease is made subject to the covenants and restrictions in this Declaration."

Is revoked, deleted, removed and replaced by:

"No unit shall be used for any other purpose other than a dwelling place for a single family and for purposes necessarily incidental thereto. Each unit shall be occupied by the owner of that unit, and no leasehold interest or general tenancy in others shall be created by the owner of any unit. The above requirement of owner occupancy and prohibition against leasehold interests or general tenancies shall become effective within ninety (90) days of the recording of an amendment creating such a requirement and prohibition with the office of the Montgomery County Recorder, providing that such amendment shall not affect the existing term of any lease in effect at the time of such recording.

Units that are leased prior to the effective date shall be allowed to continue leasing activities until ownership of that Unit is transferred, whereupon the Unit shall be owner occupied for a single family as mandated above."


